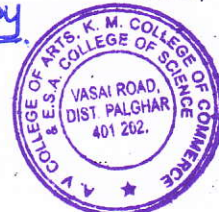
This has reference to your application for extension of affiliation for teaching the **course of B.Com.(Banking & Insurance)** from the academic year 2005-2006.

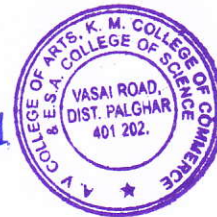

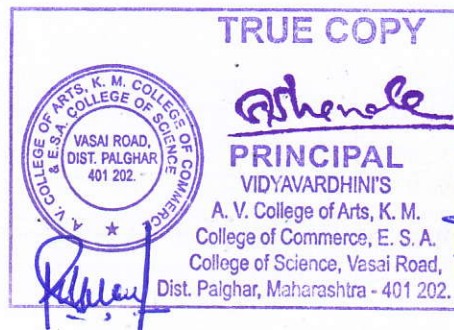


