"Resolved that the report of the Local Inquiry Committee be accepted and that in accordance therewith it be recommended to the Academic Council that Vidyavardhini's Anna-saheb Vartak College of Arts, Kedarnath Malhotra College of Commerce and E.S. Andrades College of Science, Vasai, Thane, be granted recognition to enroll not more than three (3) students for the M.Sc. degree (By Research) in the subject of Zoology, for a period of five (5) years, subject to the conditions that the College authorities gives an undertaking in writing that they will fulfill the following conditions to the satisfaction to the Academic Council :-

- 1) that the College will spend at least Rs.15,000/- towards equipments;
- 2) that the College will spend at least Rs.10,000/- towards purchase of relevant reference books and journals;
- 3) that the other digible teachers of Zoology Department should get themselves recognized for Post-graduate teaching."

The above recommendation was accepted by the Academic Council at its meeting held on 13th June, 2008 vide item No.8.4.

Pursuant to the above resolution of the Board of University Teaching and Research (B.U.T.R.) for the faculty of Science, I am directed to inform you that the Vidyavardhini's Annasaheb Vartak College of Arts, Kedarnath Malhotra College of Commerce and E.S.
