



MEMORANDUM OF UNDERSTANDING

The MOU is made on this 19th December 2018 at Mumbai between A.V. COLLEGE OF ARTS, K.M. COLLEGE OF COMMERCE & E.S.A. COLLEGE OF SCIENCE, VASAI ROAD having its Registered Office at VASAI ROAD and NATIONAL INSURANCE COMPANY LTD. Having its Head Office at KOLKATA.

National Insurance Co. Ltd. ('NATIONAL') has made a final offer vide letter dated _______ to renew the "Yuva Raksha" Student Group Insurance Scheme which to cover the College and University Students under a Group Personal Accident policy coverage including death, permanent disability or hospitalization expenses arising out of accident covered under the policy. Participation in any adventurous sports and hazardous activities has to be with prior consent of the College / Department / Institute's authorities. 24 hours coverage will be within India and outside India for 1 year.

The premium rate quoted by 'NATIONAL' as mentioned in the report of the meeting held on 6th May, 2005, is final and will not undergo any change for a period of one year so long as the group size does not exceeds Two lakhs students.

Designated colleges of the University will collect the premium amount from the students at the time of admission when the fees are collected. In case College / Department / Institute wants to pay premium in advance the same will be accepted as a deposit premium.

Such premium will be transmitted (alongwith the list of Students) to the following office of "NATIONAL". An annual policy will be issued by "NATIONAL" covering the students from the day the premium cheque is handed over to them.

At the time of admissions the concerned colleges would be provided brochures for student lying down the scope of cover as also the claim procedure and documents to be submitted at the time of claim.

All claim payments will be made to the individual students or to their parents / legal guardians as appearing in the admission forms.

This MOU signed between Principal / Department Head / Director and the Divisional Manager of National Insurance Co. Ltd. on 18 DEC 2018 will be valid for a period of one year from the date of execution.
