Title of Practice: Sahitya Katta (Literary Platform)

Objectives of the Practice:

1. To develop literary abilities among students

The Practice:

'Sahitya Katta' is a literary platform started on our college campus. It is an

open place where teachers and students come together to discuss various literary

aspects. This is a golden opportunity for all college students interested in language

and literature. This platform stimulates young students, budding literary scholars,

poets, writers, and essayists.

Mrs. Ashwini Shinde, a famous anchor and writer, inaugurated the Sahitya

Katta on 16th March 2022. Mr. Pandurang Naik, Vice-President of our

Vidyavardhini institution chaired the program. Prin. Dr. Arvind Ubale also presents for the program. The intention of starting *Sahitya Katta* is to develop the creative minds of students. Departments like Marathi, English and Hindi especially take an interest in *Sahitya Katta* and organise many literary activities for the students. Sometimes, teachers take their lectures on *Sahitya Katta* if a classroom is unavailable, especially during the examination period. Even they take lectures on *Sahitya Katta* to make the teaching-learning process enjoyable.

Teachers from various department specially Marathi, Hindi, and English stimulate students to participate actively in literary activities presented on *Sahitya Katta*.
