Sir / Madam,

The Institute of Company Secretaries of India (ICSI) is a Statutory Body constituted under an Act of Parliament, viz. Company Secretaries Act, 1980 to regulate and develop the profession of company Secretaries. The Institute functions under the administrative jurisdiction of the Ministry of Corporate Affairs, Government of India.

The affairs of the Institute are managed by a Council composed of fifteen persons elected by the Members of the Institute from the four Regional Constituencies viz. Eastern, Northern, Southern and Western India Regional Constituencies and five persons nominated by the Central Government. Election of each of four Regional Councils are also conducted simultaneously on the same date and time as scheduled for the Council election.

The tenure of the Council and each of four Regional councils are of four years which gets re-elected after expiry of its term. The tenure of the present (13th) Council is till 18th January, 2023. In order to constitute new (14th) Central Council and Regional Councils at each of four Regions of the Institute, the tentative date election is scheduled on 9th & 10th December, 2022.



In view of the above, we seek confirmation for setting up of polling booth towards Election of ICSI on **9th December, 2022 from 7 AM to 9 PM** in your college premises as per the attached format. The total number of voters at the said polling booth shall be around 1000. For the purpose we would require Infrastructure arrangements such as tables, chairs, toilet, water and electricity facility. Exact requirement would be one table and three chairs for seating of polling officer and supporting staffs. One table would be for making polling booth for voting. Around 20-25 chairs extra (in case 10-15 members come together for voting then to make the arrangements in waiting area).
